Regulations of the 2020 Sambo World Cup «A. Kharlampiev Memorial» (sports sambo M&W, combat sambo M)

Moscow

1. Purpose of the competition

- Popularization of sambo worldwide;
- Improvement of sambo mastery of athletes;
- Strengthening of sports friendly relations.

2. Dates and Terms

The 2020 Sambo World Cup «A. Kharlampiev Memorial» (sports sambo M&W, combat sambo M) - (hereinafter - Competitions) will be held in Moscow at Luzhniki Small Sports Arena (MSA Luzhniki) at the address Luzhnetskaya naberezhnaya, 24/3 on December 17-20, 2020, the day of arrival is December 17, and the day of departure is December 20.

3. Management on organization and holding of the Competitions

General management of the organization and holding of the competitions is carried out by the International SAMBO Federation (hereinafter FIAS), Ministry of sports of the Russian Federation (hereinafter Minsport of Russia), «All-Russian sports and sports public organization Russian Sambo Federation» (hereinafter Federation), Department of sports and tourism of Moscow (hereinafter Moskomsport) and Regional public organization "Sambo Federation of Moscow" (hereinafter Sambo Federation of Moscow).

The powers of the Minsport of Russia as organizer of the international competitions are carried out by the Federal state autonomous institution "Management on organization and holding of sports events".

Direct holding of the competitions is assigned to the Federation and the Referees panel approved by the International SAMBO Federation (FIAS).

4. Participants of the Competitions and participation terms

The Competitions will be held according to the regulations for organizing and holding of the official FIAS competitions (sport and organizational rules) (hereinafter Regulations). **The World Cup is held within one final stage.**

The Competitions will be held in the following weight categories:

- sports sambo (men) -52, 57, 62, 68, 74, 82, 90, 100, +100 kg;
- sports sambo (women) 48, 52, 56, 60, 64, 68, 72, 80, + 80 kg;
- combat sambo (men) -52, 57, 62, 68, 74, 82, 90, 100, +100 kg.

National sambo federations affiliated to FIAS have the right to take part in the Competitions (athletes not younger than 2002).

Composition of the delegation: 59 persons, including 54 athletes, 3 coaches, 1 doctor, 1 head of the delegation.

Not more than 2 athletes per weight category from national team is allowed to take part in the competition.

To enter the Russian Federation and participate in the competitions, each team member must pass COVID-19 PCR test in their respective countries and have a negative result taken no earlier than 72 hours before arrival. The test results must be sent by e-mail to the Organizing Committee of the competitions, and a hard copy presented at the accreditation.

5. Accreditation

The heads of national teams participating in the Competition should submit documents confirming the payment of the FIAS annual membership fee to the FIAS authorized official (the payment order with a bank mark of money transfer).

Heads of delegations must also provide the following documents to the secretariat: entry form copy, passport or other identification document.

6. FIAS License and Insurance of the participants

The cost of the FIAS license is 60 USD, which also includes international sports insurance for the selected FIAS competitions. These competitions are included in the list of FIAS international competitions included in the insurance program for 2020 (the terms and conditions of Insurance are provided upon the request of the NSF at info@sambo-fias.com; the NSF is responsible for informing of athletes and officials with the Insurance Rules in advance). Each participant paying 60 USD for the FIAS license fee is automatically included into the insurance programme and gets a medical sports insurance. According to the insurance programme rules it is not prohibited to have another insurance but the price for license will remain 60 USD.

License payment and insurance of participants of the Competitions should be executed by the National Sambo Federations whose teams take part in the Competitions.

7. Doping control

The doping tests are carried out by the official regional anti-doping agency recognized by WADA. The selection of athletes for tests will be run according to the FIAS Anti-Doping provisions 2015 based on WADA Anti-Doping Code 2015.

After receipt of notification until arrival at the point of doping control the selected athletes will be always accompanied by the official representative of the organization. The appointed person (his/her corresponding representative in accordance with FIAS Anti-Doping regulations 2016) may accompany the athlete. If the Organizing Committee does not provide participants with accreditation with the photo on it, the selected athlete will be required to provide a valid passport or identity document at the point of doping control. All athletes are required to plan in advance the date and the time of their departure after the end of the competitions taking into consideration that any athlete could be chosen for doping test.

8. Results of the Competitions

The order of bouts, the winners and prize-winners of the Competitions should be defined in accordance with the international sambo competitions rules (for sports and combat sambo). The type is individual Competitions.

9. Awarding

The winners and prize-winners of the Competitions will be awarded with the medals and diplomas. Other organizations may provide additional awards and prizes.

10. Financial terms

The expenses related to the participation in the Competitions should be covered by the sending organization.

The heads of delegations must fulfil all financial obligations with the Organizing Committee on the day of arrival and settle the accreditation requirements: 100 USD per day per person for accommodation and meals (two times a day); 20 USD per person for transfer *airport-hotel-arena-airport*.

FIAS shall pay the travel expenses and the work of the Chief Referee and Chief Secretary at the rate of 100 USD for each day of the competitions, included the days of arrival and

departure as well as the work of 25 referees at the rate of the 50 USD for each day of the competitions excluding arrival and departure days.

11. Media

The Organizing Committee of the Competitions provides all the necessary conditions for work of media representatives at the Competitions in compliance with FIAS media guide.

To be accredited a media representative must preliminarily complete the appropriate accreditation form in the section *Media center - Accreditation* on FIAS official website <u>www.sambo.sport</u> by specifying in the *Comments* section the name of the Competitions 2020 Sambo World Cup «A. Kharlampiev Memorial». This form must be completed no later than March 10, 2020.

12. Television

All broadcasting rights of the Competitions belong to FIAS. The Organizing Committee provides the broadcast of the Competitions in accordance with FIAS television guide.

13. Marketing and advertising

The Organizing Committee of the Competitions guarantees the observance of sponsorship rights to the FIAS sponsors and partners in compliance with FIAS marketing guide.

14. Security

The Competitions are held in the sports venue included in the All-Russian register of sports venues in accordance with the Federal law from December 4, 2007 № 329-FZ "Physical culture and sport in the Russian Federation" meeting the requirements of the relevant normative legal acts acting on the territory of the Russian Federation and aimed at ensuring public order and security of participants and spectators, as well as meeting the requirements of the Regulations.

15. Application for participation

The Application forms for participation in the Competitions should be submitted by the National Sambo Federations no later than December 1, 2020 in accordance with the Regulations.
