



REGULATION
OPEN EUROPEAN SAMBO CUP BELARUS (M&W, COMBAT SAMBO M)
11-14 FEBRUARY 2022

1. General terms.

- 1.1. Open European Sambo Cup 2022 (M&W, Combat Sambo M), hereinafter referred to as Open European Sambo Cup 2022, is held in accordance with the International Sambo Rules adopted by FIAS.
- 1.2. Open European Sambo Cup 2022 will be organized and held by the European Sambo Federation and the Republic organization «Byelorussian sambo federation».
- 1.3. Open European Sambo Cup 2022 will be held with the aim of promoting and developing sambo in Europe and strengthening international relations.

2. Competition organizers.

3. Dates and venue.

- 3.1. Open European Sambo Cup 2022 will be held from February 11 to 14, 2022 in Minsk, Republic of Belarus.
- 3.2. Venue of the competition: State Cultural and Sports Institution "CHIZHOVKA-Arena" (Minsk, 19 Tashkentskaya str.).
- 3.3. Place of accommodation for competitors: hotel "Arena", Minsk, 19 Tashkentskaya str.
- 3.4. Accreditation of teams and competitors will be carried out at hotel "Arena" (Minsk, 19 Tashkentskaya str).

4. Terms of participation.

- 4.1. European Sambo Open Cup 2022 takes will be held as an open championship format.
- 4.2. Athletes born in 2004 and above are eligible to participate in the 2022 European Sambo Open Cup.
- 4.3. Not more than 4 competitors in each weight category per country are allowed to compete.
- 4.4. To participate in the competitions, each team member must pass COVID-19 PCR test in their respective countries and have a negative result taken no earlier than 72 hours before arrival. The test results must be sent by e-mail to the Organizing Committee of the competitions, and a hard copy presented at the accreditation.
- 4.5. The PCR-test results must be sent by e-mail to the Organizing Committee of the competitions, and a hard copy presented at the accreditation
- 4.6. To enter the territory of the Republic of Belarus <https://gpk.gov.by/covid-19/en/>
- 4.8. Registration of the athletes is made ONLY by means of the FIAS Electronic System (FIAS Database) at <https://fms.sambo.sport/login>. Admission of the athletes to the



competitions will be carried out through the Database only. All questions related to the registration in FIAS Database should be addressed to FIAS at info@sambo-fias.com or +7 (495) 4116137 as well as checked at the FIAS YouTube channel:

4.7. National federations that fail to submit their entries by October 27, 2021 through the FIAS Database will be obliged to pay the fine of 200 USD per each delegate, who is not registered for the competitions (FIAS Database registration onsite will be obligatory anyway).

4.8. Republic organization «Byelorussian sambo federation» will provide visa support only to those delegations which apply through the FIAS database.

5. Technical specifications.

5.1. Weight categories:

Sport and combat sambo (men)	58, 64, 71, 79, 88, 98, + 98 kg.
Sport sambo (women)	50, 54, 59, 65, 72, 80, + 80 kg.

5.2. The 2022 European Sambo Open Cup is held in accordance with the FIAS International Sambo Rules and the FIAS Sports Organising Rules

5.3. Every athlete must undergo a medical examination before leaving for the competition, and the results of the medical examination must be entered on the entry form or medical certificate.

5.4. The Organizing Committee guarantees first aid to all participants in the sports delegations.

5.5. All participants, coaches, referees and representatives must have medical insurance. The insurance will be checked at weigh-in. Without health insurance athletes are not allowed to participate in the championships.

5.6. 5 referees (head referee, chief secretary, deputy head referees) of international category appointed by the Chairman of the FIAS Technical Commission shall be allowed to officiate at the European Sambo Open Cup 2022:

- 5 referees (head referee, head secretary, deputy head referees) of international category with a valid FIAS licence, appointed by the Chairman of the FIAS Technical Commission;

- 10 judges appointed by the Chairman of the FIAS Officiating Commission.

5.7. The travel and salary of 5 judges shall be provided by FIAS.

5.8. The salaries of 10 judges shall be paid by the EFS.

5.9. Payment for accommodation of 15 judges is provided by the Organizing Committee.

5.10. All delegations must have an audio recording of the national anthem on an electronic medium and the national flag (2 pcs. 1*2 meters)

6. Financial terms.

6.1. Each member of the delegation must pay a fee to the Organising Committee for accommodation and two meals per day per delegation member (triple room - 80 USD, double room - 100 USD; single room - 150 USD) (only in official hotels).

6.2 Airport-hotel-arena-airport transfer cost - 20 USD for each member of the delegation.

6.3 Heads of delegations must fulfill all financial obligations to the Organizing Committee of the competition on the day of arrival and meet all conditions for accreditation.

6.4 Competitors who have arrived to participate but have not been included in the final entry form by __ February 2022 will be required to pay 120 USD per day of accommodation

6.5. The Organising Committee provides meals and accommodation for the EFS President, EFS General Secretary, Head of the Referee Commission, Chief Referee, Chief Secretary and 15 Judges in accordance with EFS rules.



6.6 Each athlete* and coach** must register in the FIAS Database and hold a FIAS licence with payment of the membership fee for the current year.

6.7 The cost of the annual license for the athlete and coach is 60 USD: of which 35 USD is the membership fee for the year, 25 USD is the international sports medical insurance***.

*An athlete who has not registered in the FIAS Database and has not paid the membership fee for the current year will not be allowed to participate in the European Open Cup.

** A coach without a FIAS license, without registration in the FIAS Database and without paying the membership fee for the current year, may attend the European Open Cup only as a spectator (will not be admitted to the competition area).

*** The rules of the insurance programme do not prohibit having any other insurance, with the cost of the licence remaining the same at \$60 US. Any official delegation member wishing to be included in the FIAS insurance scheme may do so by paying a fee of \$60 US.

6.8 Payment of the annual licence fee for athletes (coaches) shall be made by the National Federation and/or the athlete (coach) no later than one month before the competition.

6.9 The payment of annual licenses of athletes and coaches shall be made through the FIAS Database.

6.10. Athletes or coaches arriving for the European Open Cup who have not paid the annual licence in due time will pay the annual licence and a fine of 40 (forty) USD on the spot.

6.11. Each national federation is obliged to pay the annual membership fee to the EFS in the amount of 300 (three hundred) euros according to the EFS regulations.

7. Rating.

7.1 The European Open Cup is included in the list of FIAS Ranking Tournaments.

7.2 The conditions for obtaining and the procedure for calculating ranking points shall be in accordance with the FIAS Ranking list for 2022.

8. Doping control.

8.1. No doping control at the Open European Sambo Cup.

9. Awarding of winners.

9.1. Prize-winning athletes shall be awarded with medals, diplomas and gifts.

10. Official ceremonies.

10.1 The athletes shall wear red uniforms at the prize giving ceremony.

10.2 National anthems will be played and national flags will be raised in honour of the winners.

10.3 Representatives of the national federations will only be admitted to the VIP area in appropriate attire; admission in sportswear will be restricted.
