# INFORMATION DOCUMENT FOR THE INTERNATIONAL OPEN "GRAND PRIX DE PARIS-ROISSY PAYS DE FRANCE" SAMBO SPORT AND COMBAT 2025 VILLEPARISIS

#### 1. General Terms

1.1 The international Open "Grand Prix de Paris-Roissy Pays de France, de sambo sportif et sambo combat 2025" (juniors, hopes, seniors M-F) will be held in accordance with the current international rules of sambo.

current international sambo rules.

1.2 The Paris-Roissy Pays de France Grand Prix will be organized by the National Sambo Sports Commission.

1.3 The Grand Prix of Paris-Roissy Pays de France is organized to popularize and develop sambo and strengthen international sports relations. All countries are allowed to participate.

#### 2. Organizers of the competition

2.1 The overall organization and management of the Grand Prix de Paris-Roissy Pays de France will be the responsibility of the Full Sambo Evolution club and the National Sambo Sports Commission.
2.2 Contacts of the organizers Bruno SCHMITT, Head of Full Sambo Evolution Club
(sambo.idf@free.fr), Abdelhak BOUSNANE, Head of CSNS Events (csns.evenements@gmail.com), Isabelle KIBWAKA, Deputy Secretary General of CSNS (csns.secretariat.general@gmail.com), and Audrey JOUBERT, National Arbitration Manager (polearbitragesambofrance@gmail.com)

#### 3. Dates and location of the event

3.1 The Grand Prix de Paris-Roissy Pays de France will be held on Saturday, May 31, 2025

3.2 The venue for the event is Gymnase Géo André, 77270 Villeparisis

3.3 Registration will take place at the Gymnasium on Friday, May 30th, between 6 PM and 8 PM, before the weigh-ins for all categories.

3.4 Hotel/gymnasium transfers, accommodations, and meals are the responsibility of the competitors and their companions. The transportation between the hotel and the gym, accommodations, and meals are the responsibility of the competitors and their companions. NB: There will be no shuttle service provided by the organizer.

#### 4. Conditions of participation

4.1 Athletes, clubs, and/or national sambo federations have the right to participate in the competitions.

4.2 The registration deadline by email to csns.secretariat.general@gmail.com and csns.evenements@gmail.com is set for May 18, 2025, at midnight.

4.3 The financial participation is set at €20 for an athlete who will only participate in one discipline (sport or combat); if the athlete registers for both disciplines (sport and combat), the participation rises to €30. The participation fee is payable in advance to the CSNS (Bank Account Statement attached). Your transfer notice must be attached to the list of participants. es

4.4 Categories by age and weight: the table of weight and age categories is attached to this document.

#### 4.5 Athletes born in 2009, 2008, and 2007 are considered youth.

#### 5. Technical details

5.1 The Grand Prix of Paris-Roissy Pays de France will comply with the rules in force for international sambo competitions. The officiating of the competitions will be entrusted to a group referees approved by the CSNS arbitration department

5.2 The draw will be conducted manually in public after the weigh-in, with a random assignment of competitors.

5.3 The competition system with elimination and consolation for the finalists (simple repechage) will be applied.

5.4 The Organizing Committee commits to providing first aid (if necessary) to all participants. 5.5 Each athlete must undergo a medical examination for fitness in competitive sambo before departing for the competition; the results of this medical examination, or a medical certificate, must be included in the application.

5.6 At the time of registration, all national delegations must provide the Organizing Committee with a short version (no more than 30 seconds) of their national anthem in electronic format.

#### 6. Anti-doping

6.1 Doping tests may be conducted randomly by the official organization.

6.2 Team representatives must carefully plan the departure dates and times after the competition, taking into account that athletes may be selected for doping control.

#### 7. Financial Conditions

7.1 Each athlete must be licensed with a club and with their national federation. He must be covered by international sports insurance. The contributions and insurance of the competitors are covered by the clubs or national federations in case of an accident.

#### 8. Rewards

8.1 The awarded athletes will be rewarded with medals and, possibly, with sambo combat champion belts.

8.2 The clubs will also be rewarded with trophies.

8.3 The red sambo uniform is required for official ceremonies

8.4 During the official ceremony, the national anthem will be played, Appendix 3

(\*) A "make-up weigh-in" may be offered on the morning of the competition, if it is mentioned in the circular. In this specific case of a "catch-up weigh-in," the fighters must be at the weight and in the category announced at the time of their registration. If an athlete weighs more than the maximum allowed weight for their category, they will not be able to move up to the higher category and, consequently, will not be able to participate in the Grand Prix of Paris-Roissy Pays de France. (This "catch-up weigh-in" is offered to competitors who do not live too far away and to spare them a night in a hotel.) But this arrangement should not disrupt all the pre-registered schedules.

## CSNS INTERNATIONAL COMPETITION REGULATIONS SPORT SAMBO – COMBAT SAMBO

#### 1. Insurance

Sambo athletes who present at the administrative check before weigh-in with a current year FFLDA license stating "Insurance: No" must provide, at the same time, a certificate from their insurance indicating coverage for Sambo competitions.

All foreign athletes must be able to present valid insurance.

#### 2. Registration Fees

Each athlete must pay a registration fee of €20 for participation in one discipline (Sport OR Combat) and €30 for participation in both disciplines (Sport AND Combat).

Payment must be made in advance via bank transfer only (Bank Account Details attached). A copy of the transfer receipt must be included with the registration.

#### 3. Medical Certificate

#### a. Sport Sambo

Competitors must present a medical certificate less than one year old confirming no contraindication to competitive Sambo.

#### b. Combat Sambo

Competitors must present at weigh-in:

• A medical certificate, less than one year old, confirming no contraindication to Combat Sambo, issued by a doctor holding a C.E.S., D.E.S.C., or a qualification in sports medicine and biology (the doctor's stamp, header, or written credentials are required). The medical examination must include:

- Neurological and mental health check
- Eye examination: visual acuity and visual field
- A sworn statement confirming the athlete has not suffered a knockout with loss of consciousness in the 28 days prior to the competition.

#### 4. Surgical Intervention Authorization

Each year, the athlete or their parent/legal guardian (if a minor) gives or denies consent for club officials to authorize emergency medical treatment if necessary. Hospitals may not always recognize this authorization, so it is advised to obtain one for each event. Medical professionals legally require express parental consent to intervene.

#### 5. Parental Authorization to Compete

Parents or legal guardians of minor license holders must give or deny consent each year for the athlete to compete in regional and/or national competitions and allow travel.

#### 6. Official Attire

#### a. Athletes

The first Sambo athlete called to the mat wears red; the second wears blue. Competitors who show up with non-compliant Sambo attire will not be allowed to compete.

• They will have 2 minutes to return in proper attire, or they will be disqualified (match lost).

- Penalties also apply:
  - Verbal warning for delays between 30 seconds and 1 minute
  - First warning and 1 penalty point for delays between 1 and 1.5 minutes
  - Second warning and 2 penalty points for delays over 1.5 minutes

#### Sport Sambo Attire:

- Kimono jacket (Kurtka): one red, one blue
- Tight shorts matching the jacket color (Trusi) no flashy or patterned shorts
- Soft-soled Sambo shoes (Bortsovki); rigid soles are prohibited
- Integrated belt in the color of the jacket or corresponding to the athlete's real rank

#### Combat Sambo Attire:

#### Same as Sport Sambo, plus:

• MMA-style gloves: open fingers, covering the first phalanges, red or blue, with significant foam padding (approved gloves only). Bag gloves are prohibited

Open-face helmet, no cheek protection, no metal fasteners, color matching jacket

• Soft shin guards, no hard shells, covering shin and



- foot, color matching jacket
- Approved mouthguard

Groin protector (men)

Chest protector (women only)



#### b. Coaches

Coaches are allowed in the competition area only in tracksuits and sports shoes or proper civilian clothing (no shorts or flip-flops).

They must remain seated during fights and show respect toward referees, athletes, and other coaches.

#### c. Referees

Approved referee attire includes:

• For federal and international referees: CSNS official polo shirt (one red sleeve, one blue), navy pants, or white shirt with red/blue cuffs, black pants, Sambo shoes, and a whistle.

• For regional, departmental referees, officials, and trainees: white shirt with red/blue cuffs, black pants, Sambo shoes, and a whistle.

#### 7. Competition Format

#### a. Weight Categories with Fewer than Six Competitors They will fight in a single round-robin pool (Nordic tournament).

Following the draw and before assigning match order, last year's finalists in each age and weight category will receive a number ensuring they meet in the final round.

**b. Tiebreaker in Pool Competitions (2 competitors with equal points)** Ranking is determined as follows:

- 1. Number of matches won
- 2. Method of victories:
  - Submission win: 5 points
  - Total victory: 4 points
  - Win by large superiority (8+ point difference): 3 points
  - Win by small superiority (1 to 7 point difference): 2 points
  - Victory by warning: 1 point
  - Defeat with at least one point awarded: 1 point
  - Note: Victory by opponent's forfeit grants the highest score (5 points) to the winner.
- 3. If there is still a tie between two fighters at this stage, priority is given to the winner of their direct match.

# c. Weight categories with six or more competitors will compete in a single-elimination bracket with repechage.

After the draw and before assigning seeding numbers, last year's finalists in each age and weight category will be given a seeding number to ensure separation in opposite halves of the bracket. Sport Sambo brackets will have repechage; Combat Sambo brackets will not.

#### Points awarded in bracket phase for overall ranking:

<u>**NB**</u>: Depending on the number of fighters entered in each weight category, a maximum of two consecutive weight categories may be grouped together (example: -71 kg juniors with -79 kg juniors, etc.).

#### 8. Video Refereeing

When competitions are equipped with video assistance for refereeing, it may be consulted by the mat chief, the judge, the central referee, and the head of refereeing for the competition.

#### Procedure for requesting video refereeing review:

- <u>The coach seated in the designated chair raises their hand to signal a claim (no verbal protest</u> is allowed; otherwise, the coach will be expelled).
  - a. a. If the claim is justified: the coach may submit another request.
  - b. If the claim is unjustified: the coach may no longer request video assistance for the rest of the match.
- The refereeing body will announce the result of the video review before resuming the match.

#### 9. Organization

#### a. Weigh-ins and Control

The official weigh-in schedule will be detailed in a circular for each competition.

**a1** – Weigh-ins are held the day before national competitions. Fighters must be within the weight limit by the end of the weigh-in period. If check scales are provided during the weigh-in time, only one official weigh-in is recorded.

**a2** – However, in some competitions, a "catch-up" weigh-in may be offered on the morning of the event, provided it is mentioned in the circular. In this case, athletes must strictly meet the weight and category declared during registration. If an athlete exceeds the upper weight limit of their category, they may not be moved up to a higher category and therefore will not participate in the

championship. (This catch-up weigh-in is intended for competitors who live nearby, to avoid the need for hotel accommodation, but must not disrupt pre-registered competition brackets.)

- A fighter under 88 kg will be registered in the UNDER 88 KG category.
- A fighter at **88 kg** will be registered in the **UNDER 98 KG category**.

Competitors will be weighed in their underwear in a dedicated area. Weigh-in stations are not mixed-gender (athletes and officials). Only athletes and organizers may access them.

Weigh-ins will take place the day before or on the day of the competition by random draw.

#### **NO WEIGHT TOLERANCE WILL BE ALLOWED.**

Once the draw is done, no name may be added to the list of registered participants.

#### NO CLAIMS OR EXCEPTIONS WILL BE CONSIDERED AFTER THE DRAW.

#### b. Match Duration

Timekeeping will be in real-time. Match durations must comply with the regulations (refer to the table of age categories, weight classes, and match times).

Between two matches, a competitor must have a minimum rest period of 10 minutes.

Reminder of the refereeing rule: a fighter not present in full gear after 3 consecutive calls made one minute apart will be considered "forfeit" for the match.

#### c. Emergency Services Organization

A first aid medical kit must be available at a designated area near the competition surfaces, ideally out of public view, to provide immediate care in case of accidents.

An emergency response station is required for competitions.

It is recommended to have a doctor present at national competitions and to establish a medical monitoring contract with the doctor(s) for the event.

In all cases, the doctor may make any decision regarding a competitor's participation or continuation in the competition for medical reasons. This decision is communicated to the referee and the organizer. The doctor must examine the fighter as quickly as possible and notify the referee whether the athlete may continue the match or the competition.

#### 10. Competitors must comply with the following regulations:

- Fighters must have short-trimmed nails and may not wear any metallic, plastic, or other objects that could injure or endanger the opponent. This includes any hard object directly or indirectly integrated into protective gear that could cause injury.
- Any competitor whose hair length could interfere with or hinder the opponent, in the opinion of the referee and/or judges, must have it securely tied at the back of the head.
- Makeup, jewelry (rings, piercings, etc.), head coverings, gloves, socks... are prohibited.

- Female competitors must wear a tight-fitting, short-sleeved undershirt tucked into their shorts under the jacket.
- The referee must ensure competitors are physically clean. Anyone wearing a dirty jacket must change it. If the jacket is stained with blood, it must be changed immediately. If the athlete cannot or refuses to comply, the referee will declare the opponent winner by "win by forfeit."

#### 11. Athlete and Delegation Conduct at CSNS Competition Venues

During competitions, fighters must respect the authority of the referees and accept their decisions.

After a match, competitors must maintain a respectful and dignified attitude regardless of the outcome. Displays of frustration or excessive celebration are not appropriate behaviors for a sambo athlete. Respecting these fundamental rules helps uphold the image of sambo that we should all strive to protect.

Everyone present at a competition must also pay special attention to respecting the facilities (no litter, paper, etc. in shared spaces or stands, and respectful use of restrooms and showers).

The above hygiene, uniform, and safety rules must also be observed outside the competition.

#### 12. Mobile Phones

Mobile phones are prohibited in the competition area. Their use may result in penalties or disqualification of the owner.
